1. Contact information for builder (Name, Address, Phone & Email Address)
2. Drawn at a minimum scale of 1" = 20'
3. Lot Number
4. Drainage & Utility Easements
5. Structures
6. Driveways
7. Mailbox
8. Sidewalks
9. Public Utilities
10. Utility Service Connections
11. STEP Tank Location with the 25' wide easement shown centered with the tank. The easement shall also extend 10 feet beyond both ends of the proposed tank.
