How to Protect Your Pipes This Winter

As water freezes, it expands and causes pressure on pipes. As a result, the increased pressure can cause pipes to burst. This can lead to an expensive repair for your home. That's why [it's important to take the following precautions](#) to avoid damage to your pipes this winter.



- If your home has a garage, keep the door closed -- and also close crawl space vents.
- Keep your thermostat at a temperature of at least 65 degrees.
- During times of extreme cold, let water drip from a faucet. Even small

drops will help prevent frozen pipes.

- Consider wrapping your pipes in heating tape or even newspaper. The tape only needs to be about 1/4 inch in thickness around the pipe to help with insulation.
- For outdoor items, such as water hoses, be sure to remove them from water faucets. If your home has a swimming pool, the water should be drained.
- For a more comprehensive solution to insulate your home against the cold, consider adding insulation to your attic and basement or crawl spaces. Then seal off any cracks and openings around windows, doors, and sill plates in your home.

Notable Accomplishments in 2020

Much of our work falls into three categories: water quality, maintenance of infrastructure, and support of residential and commercial growth. That said, here are some key statistics related to CUD's efforts in 2020 ...

- Completed the expansion of the K. Thomas Hutchinson Water Treatment Plant, which now delivers a capacity of up to 30 million gallons of water per day.
- Added 43 miles of water lines to our existing network of over 1,400 miles of pipe in Rutherford County. For reference, 1,400 miles is greater than the distance from Murfreesboro to Albuquerque, New Mexico.
- Flushed more than 4.6 million gallons of water and tested over 650 samples for bacteria during repairs of existing lines and at sites of new water mains.
- Flow-tested more than 420 fire hydrants.
- Processed water availability requests for over 7,100 homes.
- Maintained more than 6,600 STEP tanks through Rutherford County.
- Sold over 4 billion gallons of water in 2020.
