

Words of Wisdom From Our Experts

From Chris Forte, manager of the K. Thomas Hutchinson Water Treatment Plant: "Most of the expansion at the plant is in service, and we are ready to serve the county for the foreseeable future. It's important

for our ratepayers to know that we feed chlorine and chlorine dioxide, both of which effectively kill microorganisms such as bacteria and viruses."

From Wastewater Supervisor Joe Fisher: "We say it a lot, but it bears repeating -- Watch what you flush. Toilet paper is the only manufactured product that should be flushed."

From Director of Engineering Alan Stuemke:

- "Call TN811 before you dig. This includes planting trees, shrubs, fence posts, etc. -- anything that involves digging more than 12 inches deep.
- For all commercial accounts and residential accounts with irrigation sprinkler systems, please remember to keep your backflow preventor testing up to date.
- Fire hydrants are there to protect everyone's property, so please do NOT 'hide' them with landscaping. Every second counts in a fire emergency. Being able to quickly spot, access, and operate a fire hydrant is critical."


From Director of Operations Bryant Bradley: "Since home improvement stores are seeing heavy traffic with folks doing home and yard projects, the following are concerns from our standpoint:

- Dumping of grass cuttings and debris over the fences on the drip fields of STEP systems
- Landscaping on top of STEP tanks and around the manhole risers, which makes it difficult to access the pumps
- Large shrubs in front of the wastewater control panel at the customer's house

There should be a minimum of 20 feet cleared around STEP tank manholes. Mulch is fine in these areas. However, there should be no shrubs or trees. While contractors believe that no tree is safe to plant close to a septic system, certain species are definitely unsuitable. This includes elms, gum trees, cypress trees, maples, birches, walnut trees, poplars and willows."

Keep Paper Products and Wipes Out of the Pipes

We're asking all ratepayers to keep paper towels, napkins, and disposable wipes out of toilets. Please DO NOT flush paper towels, napkins, or disposable wipes. These items can cause a blockage or an overflow in your home and may even impact your entire neighborhood.





From the article: "Each toilet flush heads from home piping to a community's pipes, pumps and grinders for eventual treatment. The system accommodates toilet paper, which is made to disintegrate quickly in water. But wipes, diapers and other materials, which don't break down as readily, tend to clog pipes."
